




### Should Parents Have To Pass A Police Check To Volunteer In Schools?



In January 2016, the Weatherill State Government relaxed the rules on police checks for people volunteering in our public schools.

In recent years, the estimated 140,000 checks needed per year in SA created a bottleneck that saw workers and volunteers wait months to be cleared.

Recent FOI documents revealed dozens of people had failed police checks in the last two years - dozens of people who could now volunteer in schools with no check into their background.

SAASSO recently conducted a survey of members, asking parents and school staff whether all volunteers - including parents - should have to pass a criminal history check. The survey collected more than 1,000 unique responses.

- An overwhelming 94.44% of respondents stated that all volunteers - including parents should be required to pass a police check in order to volunteer in schools.
- 96% of respondents also want the Weatherill Government to increase funding so that all volunteers can be checked in a timely manner.

Parents and staff were clear in their comments that the safety of their children far outweighs the financial costs of testing all volunteers.

- 76.29% of respondents volunteer in schools.
- 22.45% work in schools.
- 90.55% identified themselves as parents.
- 94.72% of respondents had undergone a police clearance.

92% of school staff stated that the Weatherill Government should increase funding for police checks. This includes 90% of school principals.

9 out of 10 school principals want all parents checked in order to volunteer in schools.

95% of parents want all parents checked in order to volunteer in schools.


Those who had undergone a police check (95%) were far more likely to want criminal history checks for all than those who had not (70%)

Of those who do not believe parents should be police-checked, most did not volunteer in schools.




## Do you volunteer in a school?
