

SAASSO Survey 15: Bullying Law | September 19, 2017

Should The Weatherill Government Toughen Laws To Make It Easier to Prosecute Bullies - Including Jail Time Of Up To 10 Years?



In the wake of the tragic suicide of a young bullying victim, new laws are being put to the government to make it easier for police to prosecute bullies. These laws include up to 10 years jail for extreme offenders.

Both the police and the parents of the victim support the new laws - modelled on Victoria's 'Brodie's Law', people who cause physical or mental harm to another person through bullying would face up to 10 years in jail.

Last week, SAASSO asked parents and school staff what they think of tougher anti-bullying laws....

Asked if the Weatherill government should toughen laws on bullying:

- 80.12% voted 'Yes'
- 19.88% voted 'No'.

Over 1200 votes were received - with 92.98% being from parents.

51.45% of votes were from school staff - the first time school staff have been the majority of responders.

81.45% of school staff support tougher laws, compared with 79.25% of non-school staff.

Parents and non-parents were equally supportive of the proposal, with and 80.16% and 78.82% respectively voting for tougher laws.

In another first, the largest block of school staff responses came from teachers.

School staff voting yes to tougher laws, included:

- 71.65% of principals
- 80.65% of teachers
- 87.69% of SSO's
- 90.27% of 'other' school staff.

Comments showed that parents and educators acknowledge that police prosecution is a drastic step - but one that is sadly necessary to combat a plague of unchecked bullying.

School staff stated they simply do not have the resources to tackle extreme cases.

There were also numerous comments lamenting the lack of action from the Weatherill Government since the recent, tragic suicide.

Bullies need to be stopped. I applaud your leadership here.

My 11 year old daughter has been bullied for the last 12 months. This has ranged from being physically hit, emotionally hurt, psychological bullying. The school has done as much as they can for her but it is not enough. Safety is meant to be paramount with children, but that can not be provided for my child. She has been hospitalised for anxiety and failure to eat.

There is too much bullying in schools to staff as well as students. Maybe someone needs to make staff accountable for the way they treat other staff.

My son was severely bullied and was suicidal at 8. The principal supported the bullies and did not help my son. He came home bruised or bleeding every day. I brought it up with the education department and have emails to show this. Nothing was done. I would like to see teachers who actively turn a blind eye (I have proof this happened) to be held accountable.

I don't necessarily agree with jail time for teenage bullies, but community service at least to make them understand the seriousness of the consequences.

We need to have properly qualified counsellors in every school, not teachers who think they know what they're doing.

Is Close still minister?

One should not loose a life because of someone else's actions. It has become too common of late.

Personal friend of the child that died, Victim of bullying at school - schools and police need more power to stop this.

If it was a union workplace jay would be all over it.

As a deterrent, actioning consequences is a bold and positive move. I believe police need more powers to follow up on this behaviour.

Bullying can change the outcome of a child for their future and should be stopped by all ways possible.

I am a parent of a child that has self harmed themselves after traumatic bullying through several methods. There is no place for bullying in any form, in a school, community or society.

Lost my niece at 16 to teen suicide through bullying. These people need to be made accountable.
